This Privacy Notice outlines how *5th Bridge Data Technologies LLP*, hereinafter referred to as "we," "us," or "our," collect, use, disclose, transfer, and otherwise process personal data collected from you, as well as such other persons whose personal data you share with us, hereinafter referred to as "you" and "your". If there are any changes to the purposes for which you have provided your consent under this Privacy Notice, we will seek your consent for such change in the purposes of processing personal data under this Privacy Notice.

Sharing of Personal Data with Third Parties

We may share your personal data with:

- (i) **Service Providers**: For the purpose of enabling core functionality of our app, including but not limited to processing user requests, improving user experience, and providing support. This includes sharing data with providers such as OpenAI or similar API providers that power the app's core features, ensuring compliance with data protection agreements.
- (ii) **Cloud Hosting and Storage Providers**: For the purpose of securely storing and processing data necessary to run our app and ensure reliable performance.
- (iii) **Analytics Providers**: For the purpose of analyzing app usage and performance metrics, which helps us improve our services. Data shared with such providers is anonymized wherever possible.

Your Rights

Right to Access: Subject to certain conditions, and where we have relied on consent to process your personal data, or where you have voluntarily provided your personal data for a specified purpose, you have the right to obtain information from us the following, in addition to such other information as may be further prescribed under applicable law:
